# Competent authorities and their duties (Mining Act)



The ministry of Economic Affairs and Employment is responsible for the general guidance, monitoring, and development of activities under mining act.

The Finnish Safety and Chemicals agency acts as the mining authority referred to in this act. Tukes enforces compliance with mining act and manages other duties laid down herein.




# Licensing authorities (Mining Act)

Tukes as the mining authority shall make decisions concerning

- exploration permits
- mining permits
- mining safety permits
- gold panning permits

The Government shall decide on matters concerning

- a redemption permit for a mining area and on mining permits related to the production of uranium or thorium.



# Mining Act (621/2011)

## Section 32, Order of priority

- The party first applying for a permit in accordance with the provisions laid down in section 34 herein shall have priority for an ore prospecting permit, mining permit, or gold panning permit.
- For the purpose of preparing an application for an ore prospecting permit, an applicant may reserve an area for himself by submitting notification to the mining authority about the matter (*reservation notification*).



# Major phases of exploration and mining permits in Finland

1

**Reservation notification**

*Valid max 2 years*

For the purpose of preparing an application for an exploration permit.

2

**Exploration permit**

*Valid max 15 years*

An exploration permit is required for gaining a privilege exploiting the deposit. An exploration is subject to exploration permit if the property owner has not given consent to it.

3

**Mining permit**

All mines that are to be opened in Finland require a mining permit from Tukes. Mines also need a mining safety permit and a permit for handling and storing chemicals and explosives from Tukes. All mines need an environmental permit from the environmental authorities.

# EXPLORATION, Prospecting work (Section 7)

- In order to find mining minerals, everyone has the right, even on another's land, to conduct geological measurements and make observations and to take minor samples, provided that **this does not cause any damage or more than minor inconvenience or disturbance (prospecting work).**
- Prospecting work must not be carried out on the ground:
  - 1) in a cemetery
  - 2) in an area used by the defence forces
  - 3) in an area where movement is restricted or access denied to outsiders;
  - 4) on a traffic route or passage in public use;
  - 5) within 150 metres of a building intended for residential or work use
  - 6) in an area in horticultural use;
  - 7) within 50 metres of a public building or utility
  - 8) in any other area, corresponding to those in items 1–7, designated for special use.
- However, prospecting work may be carried out in an area referred to in paragraphs 2–8 **with the consent** of the authority or institution competent in the matter, or that of the relevant holder of rights.

# EXPLORATION PERMIT (Section 9 in Mining Act)

- Exploration is subject to a permit granted by the mining authority (*exploration permit*)
- **If exploration work cannot be carried out as “prospecting work” in accordance with section 7, or the property owner has not given consent to it, exploration permit is needed.**
- **An exploration permit is also required if:**
  - 1) ore prospecting could cause any harm to people’s health or general safety, damage to other industrial and commercial activity, or any deterioration in value related to the landscape or nature protection values;
  - 2) the ore prospecting is targeted at locating and exploring a deposit containing uranium or thorium;
  - 3) **the permit is necessary for gaining a privilege, as described in this act, for exploiting the deposit.**

# EXPLORATION AND MINING;

## Statement on a permit application (Section 37 in Mining Act)

- **Tukes shall request a statement on an application for an exploration permit and mining permit from the following:**
  - 1) the municipality
  - 2) the environmental authority (ELY-centre)
  - 3) the authority or institution responsible for management of the area (nature protection area, Natura 2000 area);
  - 4) if necessary, other authorities overseeing public interests in their field of activity, and the appropriate regional council.

# EXPLORATION AND MINING;

## Complaints and opinions (Section 39 in Mining Act)

Before making a decision on the matter concerning an exploration permit, a mining permit and a redemption permit for a mining area, Tukes shall reserve an opportunity for the parties involved (landowners) to lodge complaints concerning the permit matter.

Parties other than those involved (for example nature protection NGO's) shall be provided with an opportunity to express their opinions on a matter concerning an ore prospecting permit and a mining permit.

# EXPLORATION AND MINING, Publication of the permit application (Section 40 in Mining Act)

- Tukes shall inform of an ore prospecting or mining permit application by posting notice there of for a **minimum of 30 days on its notice board, and those of the municipalities involved**. Publication of the public notice shall be announced in **at least one newspaper** in general circulation in the impact area of the activity, unless the matter is of minor significance or announcing it is otherwise *prima facie* unnecessary.
- **The parties involved in particular (landowners) shall be separately informed about the public notice.**

# EXPLORATION FEE (Section 99 in Mining Act)

- The exploration permit holder shall pay annual compensation (*exploration fee*) to the owners of land included in the exploration area. The annual amount of the exploration fee per property shall be:
  - 1) 20 euros per hectare for each of the first four years of validity of the exploration permit;
  - 2) 30 euros per hectare per year for the fifth, sixth, and seventh year of validity of the exploration permit;
  - 3) 40 euros per hectare per year for the eighth, ninth, and tenth year of validity of the exploration permit;
  - 4) 50 euros per hectare for the eleventh and for further years of validity of the exploration permit.
- The exploration fee for the first year shall be paid no later than on the 30th day after the exploration permit becomes legally effective. The fee for the following years shall be paid at the corresponding time.

# ***Compensation (Section 103) and Collateral (Section 107)***

## ***Compensation for damage and inconvenience in an exploration***

- The exploration permit holder shall compensate for any inconvenience and damage caused in the exploration area by activities based on the Mining Act.

## ***Collateral for exploration***

- The exploration permit holder shall deposit collateral for the purpose of offsetting potential damage and inconvenience and performing after-care measures,


